Lights need to be changed and plumbing needs to be addressed. Existing trustees will act as "Friends of Suomi Hall" directors, with the possibility of 15 directors in total. State and Federal reports need to be filed, and Carole Lyngstad has been guiding the trustees through this process. Helen mentioned that there are lots of blackberries growing up the east side of the building. Maybe establish a "clean up" crew for this project.

Friends of Suomi Hall reported by Carole Lyngstad: There is a 2-hour conference call with the attorneys scheduled for Monday March 16th at 11am. Marvin is to give a list of directors to the attorneys. Karen has asked the lodge if there are any members present that are interested in participating as directors for "Friends of Suomi Hall". Marvin nominated Julie Overby and Michael Wagonblast. Motion to appoint Julie and Michael as directors for "Friends of Suomi Hall" was moved, seconded and unanimously approved. There is a minimum of five officer positions for "Friends of Suomi Hall", and it is encouraged that any members of the lodge, new or existing, help lend their expertise.

Auxiliary: March meeting was called to order by co-president Dea Helligso. A gift was presented to Charlotte Nyberg, outgoing secretary, as a thank you for her years as Auxiliary secretary. Katie Ryding reported the Nordic Market was very successful with 16 vendors, a pannukkaku breakfast, white elephant sale and a raffle. David Drafall reported we could have sold twice as much pannukkaku. Plans were discussed for the St. Urho's potluck, Princess Tea and the Scandinavian court visit in May. A T-shirt committee was formed to work on designs for a Friends of Suomi Hall T-shirt. The baby shower for Felicia Ginther will be held on Saturday, March 7th. All are welcome. The Auxiliary voted to donate money from the Nordic Market to add to the baby gift from the Auxiliary. Discussion was held about donating to the lodge. It was suggested \$6000 be donated with the request that \$2000 go to the lodge general fund and \$4000 go to start the Scholarship account. Approved. Scandinavian Festival Rice Pudding booth was discussed with Dea volunteering to be overall chair. Discussion was held as to do prune tarts or rice pudding for the Finnish-American Folk Festival in July. An overall chairperson is needed.

Scholarship: Scholarship members Dena Tuveng, Carole Lyngstad, Mary Cornell, Katy Pritchard, Saara Matthews, and Julie Overby have been working on the Scholarship By-Laws and application. First meeting at 3-Cups then going to email communication. Two motions were made and approved. The Lodge will establish a scholarship fund in the amount of \$8000. \$4000 from Auxiliary and \$4000 from the Lodge. The funds will be deposited into the Astoria High School Scholarship Inc. fund where they will continue to grow. Our fund will have its own name and identity within that fund and our committee will select the recipients. The committees immediate task is to finalize the application and get it out to the schools. Sara and Craig Wisti volunteered to join the committee. **Scandinavian Festival:** 2020 Midsummer Festival Court Introduction will be held at Astoria High School on Tuesday March 10, 2020 at 7pm. Next meeting will be held on Wednesday March 18th, 2020 at Peace Lutheran Church at 6:30pm.

Meet Eric Williams- Archivist



Since I've taken on the project of organizing and digitizing the Lodge's Archives. On the bright side there is a great deal of lodge material I've scanned, from Lodge business matters to Grand Lodge Convention Minutes to Grand Lodge correspondence, photos. One of my most recent discoveries in the Lodge attic was the original 1937 Historia manuscript and correspondence between lodges. It was the first definitive history of all the lodges and was found in a musty mildewed cardboard box with water damage. Lots of outdoor cleaning of the papers was required to dust away spores and remove rusty paper clips. Thankfully, all was intact and scannable. Another interesting find were a few Suomi Temperance Society letters corresponding with their attorney in regards to the well-publicized Supreme Court Case, between Matti Kemppainen, Plaintiff versus Suomi Temperance Society, Defendant in 1928.

At the turn of last century there was a great enthusiastic atmosphere for publishing Finnish ideas. Astoria had a great abundance of Finnish language publishing. Newspapers such as the Toveri, Toveritar, Lännen Suometar, Lännen Uutiset, Lännetar, had nationwide coverage to other Finnish Communities. There are literally only a hand full of newspapers that can be found. I had hoped the Astoria Public Library would have some in Its archives, but none can be found. Liisa Penner at the Clatsop County Historical Society had only a few in their collection. One of the best publications was the Veljeysviesti, starting in 1926 up until recently. The community is missing nearly half of the issues. I'm the process of digitizing these also. Many books were published here on all topics, but few can be found in. I find a great deal of Astoria material in other libraries and archives around the world but very little here, unfortunately not easily accessible to us!

Our collection of photographs is very small, I was expecting to find scrapbooks, newspaper articles, letters, etc. I've searched through the Clatsop County Historical Society for Lodge material. I found some material has been donated to them over the years but not a great abundance of Lodge photos to be found, some of our legal documents have mysteriously ended up there, along with Temperance Society Ledgers!

My mission is to preserve and document what we have or what is hidden or lost in our attics and closets. I strongly urge members or past members to make an effort to dig though their family archives. If anyone is aware of old Finnish families that had a connection to Astoria that are living elsewhere please ask if they have any materials to borrow. I would love to digitize Finnish family history materials for the Lodge Archives. We have a remarkable history that needs to be preserved and well documented. As of now I've scanned nearly 30,000 pages of documents and looking forward to doing lots more! Please contact me if you have any questions or materials to contribute.
